Application by **Bell ExpressVu Inc. (the general partner), and BCE Inc. and 4119649 Canada Inc. (partners in BCE Holdings G.P., a general partnership that is the limited partner), carrying on business as Bell ExpressVu Limited Partnership** (Bell ExpressVu LP) (the applicant), for authority to effect a corporate reorganization, through the wind-up of 4119649 Canada Inc. into Bell Canada, and for the issuance of new licences under the same terms and conditions as those set out in the current licences.

The applicant is the licensee of a national satellite relay distribution undertaking, a national direct-to-home satellite distribution undertaking, a national terrestrial pay-per-view programming undertaking, a national video-on-demand undertaking and a direct-to-home pay-per-view programming undertaking.

4119649 Canada Inc. (411) and BCE Inc., the partners in BCE Holdings G.P., the limited partner in Bell ExpressVu LP, hold an indirect 51.9% and 48.1% partnership interest, respectively, in Bell ExpressVu LP, through BCE Holdings G.P. As a result of the wind-up, Bell Canada will acquire 411's partnership interest (51.9%) in BCE Holdings G.P. and will become a partner with BCE Inc. in BCE Holdings G.P., with an indirect interest in Bell ExpressVu LP.

This transaction is for tax purposes and will not affect the effective control of Bell ExpressVu LP which will continue to be exercised by BCE Inc., a public corporation controlled by its board of directors.

The applicant is requesting new licences to be issued to Bell ExpressVu Inc. (general partner), BCE Inc. and Bell Canada (partners in BCE Holdings G.P., a general partnership that is the limited partner), carrying business as Bell ExpressVu Limited Partnership, under the same terms and conditions as those in effect under the current licences.

A true copy **must** be sent to the applicant and proof that this has been done must accompany the intervention sent to the Commission.

The Commission advises those who file and serve by electronic mode to exercise caution when using e-mail for service of documents or notification, as it may be difficult to establish that service has occurred.

Before initiating service through electronic mode, please ensure that you will be able to satisfy the Commission, upon request, that service of the notification was completed.

Each paragraph of the document should be numbered.

Your intervention should clearly identify the application and indicate whether you support or oppose the application, or if you propose changes to it, include the facts and grounds for your proposal.

In the event that the application is brought to the oral phase of the hearing, and if you wish to appear, you must provide reasons why your written comments are not sufficient and why an appearance is necessary.

Persons requiring communications support such as assistance listening devices and sign language interpretation are requested to inform the commission at least twenty (20) days before the commencement of the public hearing so that the necessary arrangements can be made.

Note that all information that you provide as part of this public process, except information granted confidentiality, whether sent by postal mail, facsimile, e-mail or through the Commission's web site at www.crtc.gc.ca, becomes part of a publicly accessible file and will be posted on the Commission's web site.
