Application by **Saskatchewan Telecommunications** to amend the licence for its terrestrial broadcasting distribution undertaking serving the above-noted locations.

The licensee proposes to replace the following condition of licence:

The licensee is authorized to distribute, at its option, WCCO-TV (CBS) Minneapolis, Minnesota, and WHDH-TV (NBC), WCVB-TV (ABC), WFXT-TV (FOX) and WGBH-TV (PBS) Boston, Massachusetts, as part of the basic service. Alternatively, for each network signal, the licensee may distribute the signal of a different affiliate of the same network located in the same time zone as that of the licensed area and included in the *Lists of eligible satellite services*, as amended from time to time.

with the following condition of licence:

The licensee is authorized to distribute, at its option, WBZ-TV (CBS), WHDH-TV (NBC), WCVB-TV (ABC), WFXT-TV (FOX) and WGBH-TV (PBS) Boston, Massachusetts, as part of the basic service. Alternatively, for each network signal, the licensee may distribute the signal of a different affiliate of the same network located in the same time zone as that of the licensed area and included in the *Lists of eligible satellite services*, as amended from time to time.

The licensee is requesting this amendment to comply with the Commission's policy as regards the distribution of the four U.S. commercial networks (CBS, NBC, ABC, FOX) and the non-commercial network PBS, specifically as it pertains to the CBS signal, in order that it correspond with the upgraded high-definition version of the signal being distributed by the licensee.
