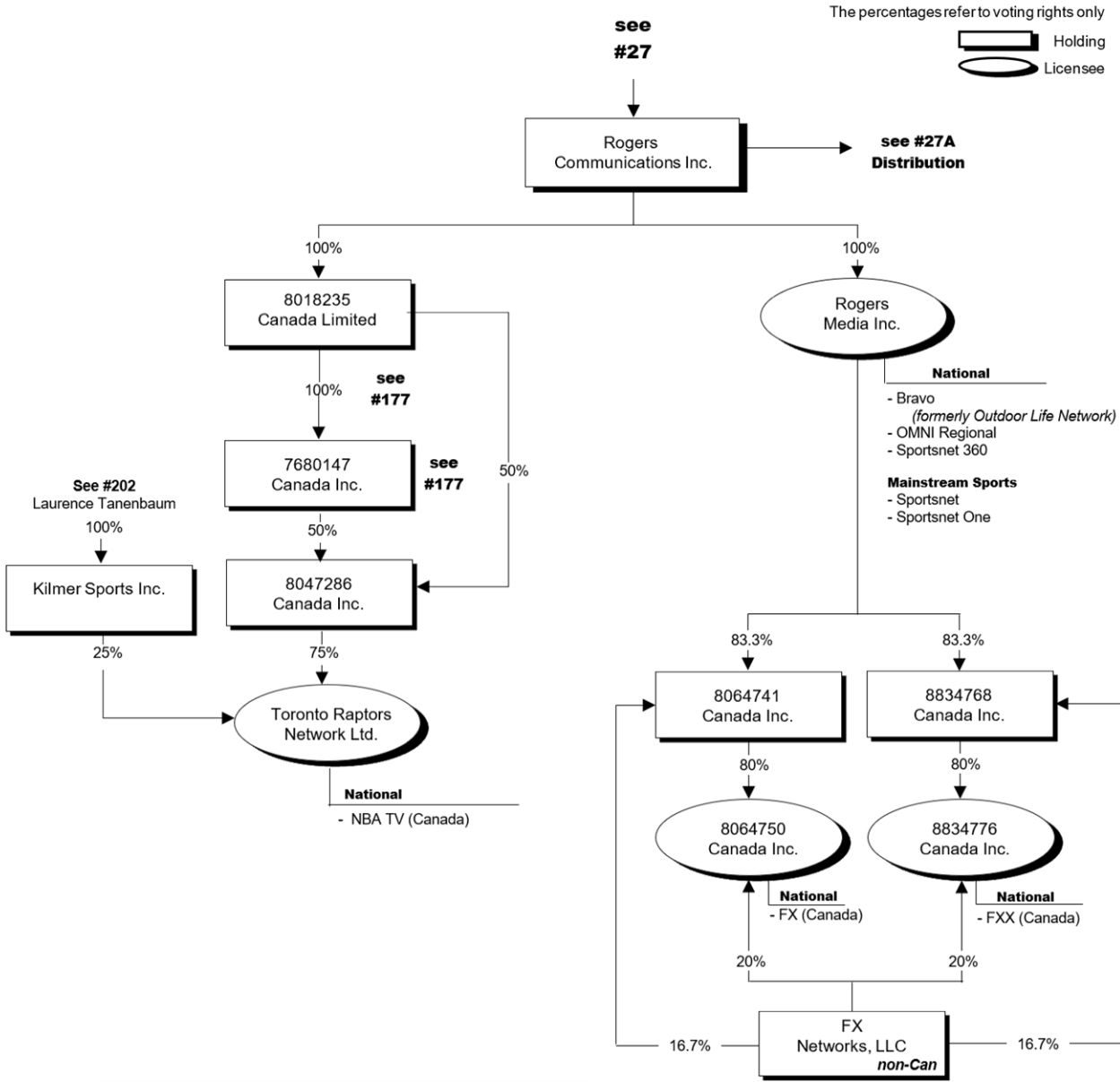


# Rogers Discretionary Services

**Update** – 2016-04-07 – The Biography Channel rebranded VICELAND (re: Rogers Media Inc.).

**CRTC 2016-238** – approved a multi-step corporate reorganization resulting in the acquisition by Vice Opco (a corporation to be incorporated) of the assets of the specialty Category A service VICELAND.

**Update** – 2016-08-22 – incorporation of 9742603 Canada Inc. and 9742638 Canada Inc. on 2016-05-06.

**CRTC – 2017-152** – approved a national, multilingual multi-ethnic discretionary service to be known as OMNI Regional proposed by Rogers Media Inc., beginning 1 September 2017.

**CRTC 2017-283** – revoked the licence issued to Rogers Media Inc. for the discretionary service G4.

**Update** – 2017-10-19 – of various types of services.

**CRTC 2018-65** – revoked the licence issued to 9742638 Canada Inc. for the discretionary service known as VICELAND.

**CRTC 2019-173** – approved a national, multilingual multi-ethnic discretionary service to be known as OMNI Regional.

**Update** – 2020-08-24 – of various types of services.

**CRTC 2022-339** – revoked the licence issued to Toronto Maple Leafs Network Ltd. for the discretionary service Leafs Nation Network (formerly Leafs TV).

**Update** – 2023-02-10 – shareholding of 8834776 Canada Inc. as per information submitted in the 2022 period of the Data Collection System.

**Update** – 2024-01-19 – shareholding of 8834776 Canada Inc. as per information submitted in the 2023 period of the Data Collection System.

**Update** – 2024-09-04 – on September 1, 2024, Outdoor Life Network (OLN) was rebranded to Bravo.

**Update** – 2025-01-28 – minor change.

**CRTC 2025-140** – approved a change in ownership and effective control of NBA TV (Canada). The shares of holding company 8047286 Canada inc owned by BCE Inc. have been transferred to Rogers Communications Inc. Accordingly, Toronto Raptors Network Ltd. is now owned by 8047286 (Rogers) (75%) and Kilmer Sports (25%). **Note:** The transaction has closed on July 1, 2025.

Rogers Communications Inc. holds 100% of Rogers Media Inc.

Rogers Media Inc. holds 83.3% in 8064741 Canada Inc. and 8834768 Canada Inc. FX Networks, LLC, a non-Canadian corporation, holds the remaining 16.7%.

8064741 Canada Inc. holds 80% in 8064750 Canada Inc. FX Networks, LLC holds the remaining 20%.

8834768 Canada Inc. holds 80% in 8834776 Canada Inc. FX Networks, LLC holds the remaining 20%.

Rogers Communications Inc. holds 100% of 8018235 Canada Limited.

8018235 Canada Limited holds 50% in 8047286 Canada Inc.

8047286 Canada Inc. holds 75% in Toronto Raptors Network Ltd. (See also chart 177 for complete ownership)

Kilmer Sports Inc. holds 25% in Toronto Raptors Network Ltd (See chart #202 for complete ownership).
