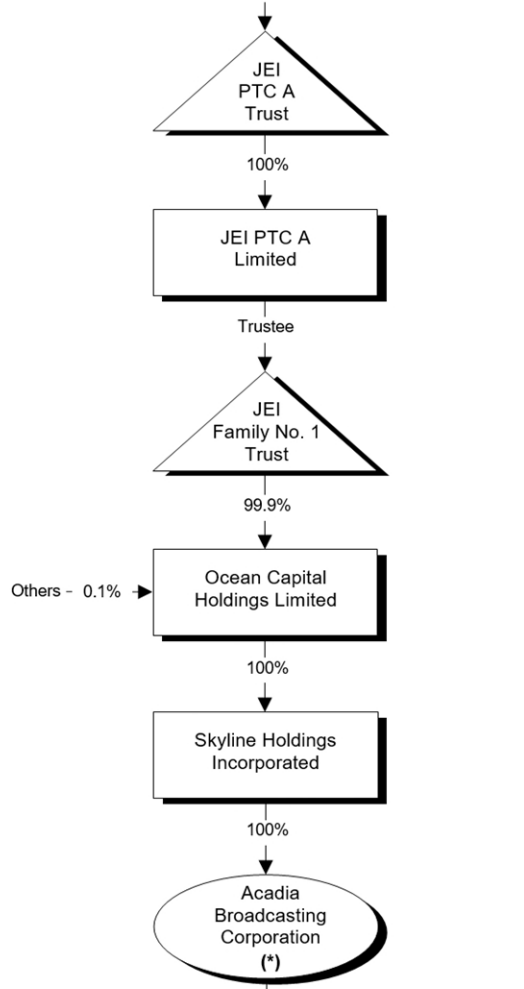

UPDATE

Amalgamation – 2017-09-01 – of Acadia Broadcasting Limited, 679823 N.B. Limited, 679821 N.B. Limited and Radio CJLS Limited to continue as Acadia Broadcasting Limited.

Administrative Decision – 2019-03-08 – approved a change in ownership and effective control of MacEachern Broadcasting Limited through the transfer of all of its issued and outstanding shares to Acadia Broadcasting Limited.

Update – 2019-10-18 – name change on 3 April 2019 of MacEachern Broadcasting Limited to CIGO Limited.

Amalgamation – 2020-09-01 – of Acadia Broadcasting Limited and CIGO Limited to continue as Acadia Broadcasting Limited.

CRTC 2021-140 – approved the acquisition by Acadia Broadcasting Limited of the assets of CKHY-FM and CKHZ-FM Halifax from HFX Broadcasting Inc.

NOTE: The transaction closed on May 31, 2021

CRTC 2021-247 – approved, as part of a corporate reorganization, the acquisition by Acadia Broadcasting Corporation of the assets of all the licensed broadcasting undertakings in Ontario, New Brunswick and Nova Scotia owned by Acadia Broadcasting Limited.

NOTE: The transaction closed on 31 August 2021

Administrative Decision CRTC L2022-0040 – 2022-08-31 – approved, as part of an intracorporate reorganization, the change in ownership and effective control of Acadia Broadcasting Corporation from being owned by Black-Tip Investments Limited (50%) and Rosa Rugosa Investments Limited (50%) and jointly controlled by John K. F. Irving and by Anne C. I. Oxley, to being owned by Skyline Holdings Incorporated. Effective control remains exercised by John K.F. Irving and Anne C.I. Oxley as Protectors of the JEI PTC A Trust, a family trust for the benefit of the children and remoter issue of John K.F. Irving and Anne C.I. Oxley. (2022-0317-3)

CRTC 2022-330 – approved the acquisition by Acadia Broadcasting Corporation of the assets of CKQV-FM Vermilion Bay and its transmitters from Golden West Broadcasting Ltd. **NOTE: The transaction closed on 1 January 2023**

Skyline Holdings Incorporated holds 100% of Acadia Broadcasting Corporation.
