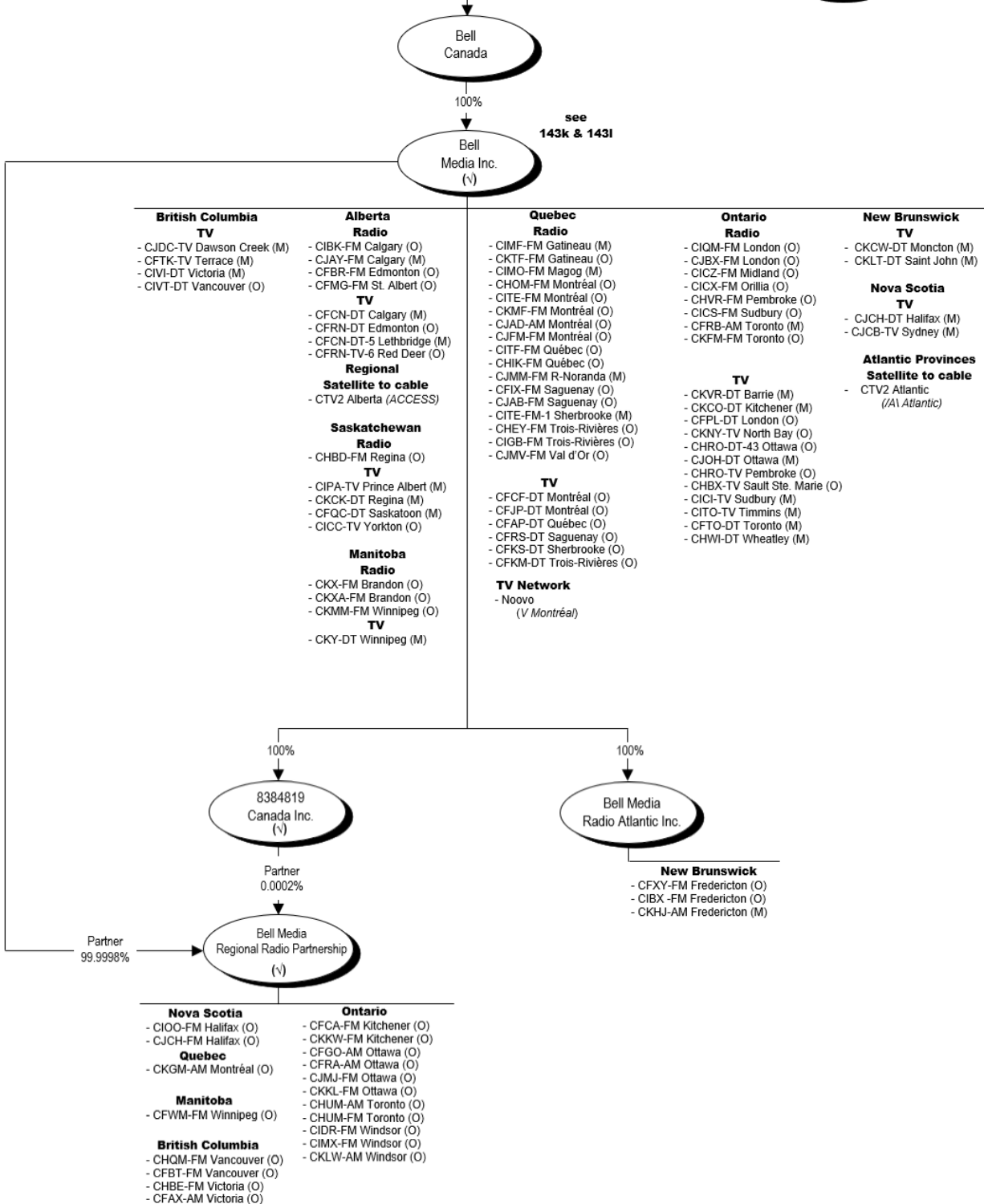

## UPDATE

**CRTC 2020-116 & CRTC 2020-154** – amalgamation of Groupe V Média inc. with its subsidiary V Interactions inc. to form a corporation, the name of which is to be determined (VFusion). After the amalgamation, all of the issued and outstanding shares of VFusion held by Remstar and other shareholders will be transferred to Bell Canada. Afterwards, Bell Canada will transfer all of the shares of VFusion to Bell Media Inc. **NOTE: These ownership changes were reflected.**

**Update** – 2020-04-14 – incorporation of 11749366 Canada Inc. on 20 November 2019.

**Update** – 2020-04-15 – amalgamation on 1 January 2020 of Learning and Skills Television of Alberta Limited, 4382072 Canada Inc., Bell Media Radio (Toronto) Inc., 11749366 Canada Inc. and Bell Media Inc. to continue as Bell Media Inc.

**Update** – 2020-05-20 – minor changes.

**Update** – 2020-08-14 – the ownership of Groupe V Média Inc. was transferred under Bell Media Inc. (see Decisions CRTC 2020-116 & CRTC 2020-154).

**Update** – 2020-09-01 – the TV network known as V Montréal changed to Noovo on 31 August 2020.

**Update** – 2020-11-19 – minor change.

**Amalgamation** – 2021-01-01 – of Groupe V Média Inc. and Bell Media Inc. to continue as Bell Media Inc.

**Update** – 2023-01-11 – of the shareholding of Bell Media Regional Radio Partnership.

**CRTC 2024-79** - revocation of the licence for CFRN-AM Edmonton issued to Bell Media Inc..

**Update** – 2024-06-10 – minor change.

**CRTC 2024-139** – approved a change in ownership and effective control of CKWW Windsor, CHAM Hamilton and CKOC Hamilton through the acquisition of assets by Neeti P. Ray (OBCI) from the partners of the Bell Media Regional Radio Partnership (CKWW) and from Bell Media Inc. (CHAM & CKOC). **Note:** This transaction closed on August 23, 2024.

**CRTC 2024-161** – revocation of the licence for CJBK-AM London issued to Bell Media Inc.

**CRTC 2024-330** – approved a change in ownership and effective control of CJOS-FM Owen Sound from Bell Media Inc. to ZoomerMedia Limited. **Note:** The transaction closed on March 31, 2025.

**CRTC 2024-336** – approved a change in ownership and effective control of CKTB, CHTZ-FM, and CHRE-FM St. Catharines, Ontario as well as CKLH-FM Hamilton, Ontario through the acquisition of assets by Golden Horseshoe from Bell Media Inc. **Note:** The transaction closed on June 16, 2025.

**CRTC 2024-344** - approved a change in ownership and effective control of the English-language commercial radio stations CKTO-FM and CKTY-FM Truro, Nova Scotia, and CKBC-FM Bathurst, CJCJ-FM Woodstock, and CIKX-FM Grand Falls and its transmitter CIKX-FM-1 Plaster Rock, New Brunswick through the acquisition of assets by Maritime Broadcasting System Limited from Bell Media Radio Atlantic Inc. **Note:** The transaction closed on April 7, 2025.

**CRTC 2025-32** – approved a change in ownership and effective control of CKPT-FM Peterborough, CKQM-FM Peterborough and CKLY-FM Lindsay via the acquisition, by Durham Radio Inc., of the assets owned by Bell Media Regional Radio Partnership. **Note:** The transaction has closed on May 5, 2025.

**CRTC 2025-44** – approved a change in ownership and effective control of 21 English-language commercial radio programming undertakings in British Columbia from Bell Media Inc. to Vista Radio Ltd. **Note:** The transaction closed on April 13, 2025.

**CRTC 2025-59** - approved the acquisition of CFJR-FM and CJPT-FM Brockville, Ontario, and CFLY-FM and CKLC-FM Kingston, Ontario from Bell Media Inc. to My Broadcasting Corporation. **Note:** The transaction closed on March 24, 2025.

**CRTC 2025-76** - approved the acquisition of CFEI-FM Saint-Hyacinthe, CFVM-FM Amqui, CFZZ-FM Saint-Jean-sur-Richelieu, CHRD-FM and CJDM-FM Drummondville, CIKI-FM Rimouski and its transmitter CIKI-FM-2 Sainte-Marguerite-Marie and CJOI-FM Rimouski, Quebec via the acquisition by Arsenal Media Inc. of the assets owned by Bell Media Inc. **Note:** The transaction closed on April 22, 2025.

**CRTC 2025-178** – revocation of the licence for the commercial radio programming undertaking CFTE Vancouver, British Columbia.

**CRTC 2025-179** – revocation of the licence for the commercial radio programming undertaking CKST Vancouver, British Columbia.

**CRTC 2025-273** - approved a change in ownership and effective control of CFRW Winnipeg. Following the close of the transaction, the assets of CFRW Winnipeg will be transferred from Bell Media Regional Partnership to Akash Broadcasting. **Note:** The transaction closed on December 23, 2025.

**CRTC 2026-108** – revocation of the licence for the commercial radio programming undertaking CKMX Calgary, Alberta.
