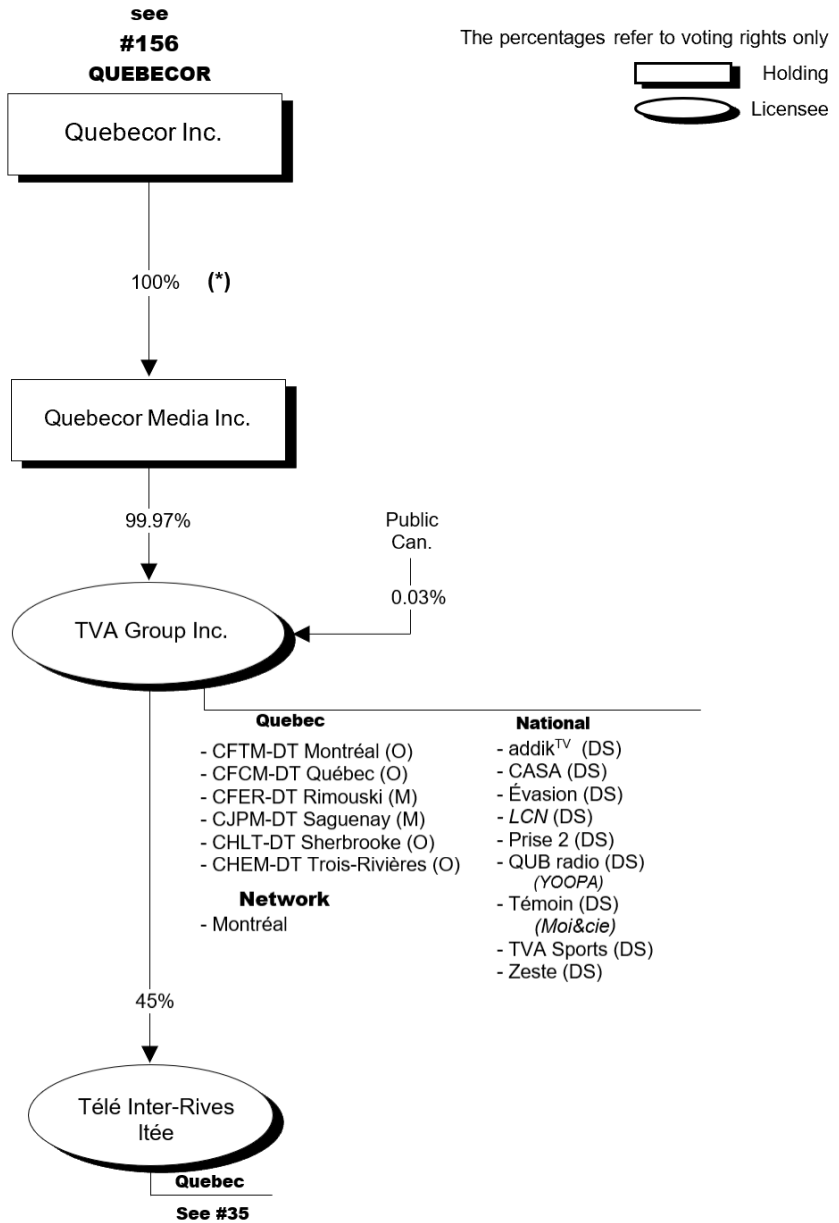

**CRTC 2019-6** – approved a change in ownership and effective control of Canal Évasion inc. and Zeste Diffusion inc., through the transfer of all of the shares of 9261-1813 Québec inc., the sole shareholder of Serdy Média inc., to TVA Group Inc., a subsidiary of Quebecor.
