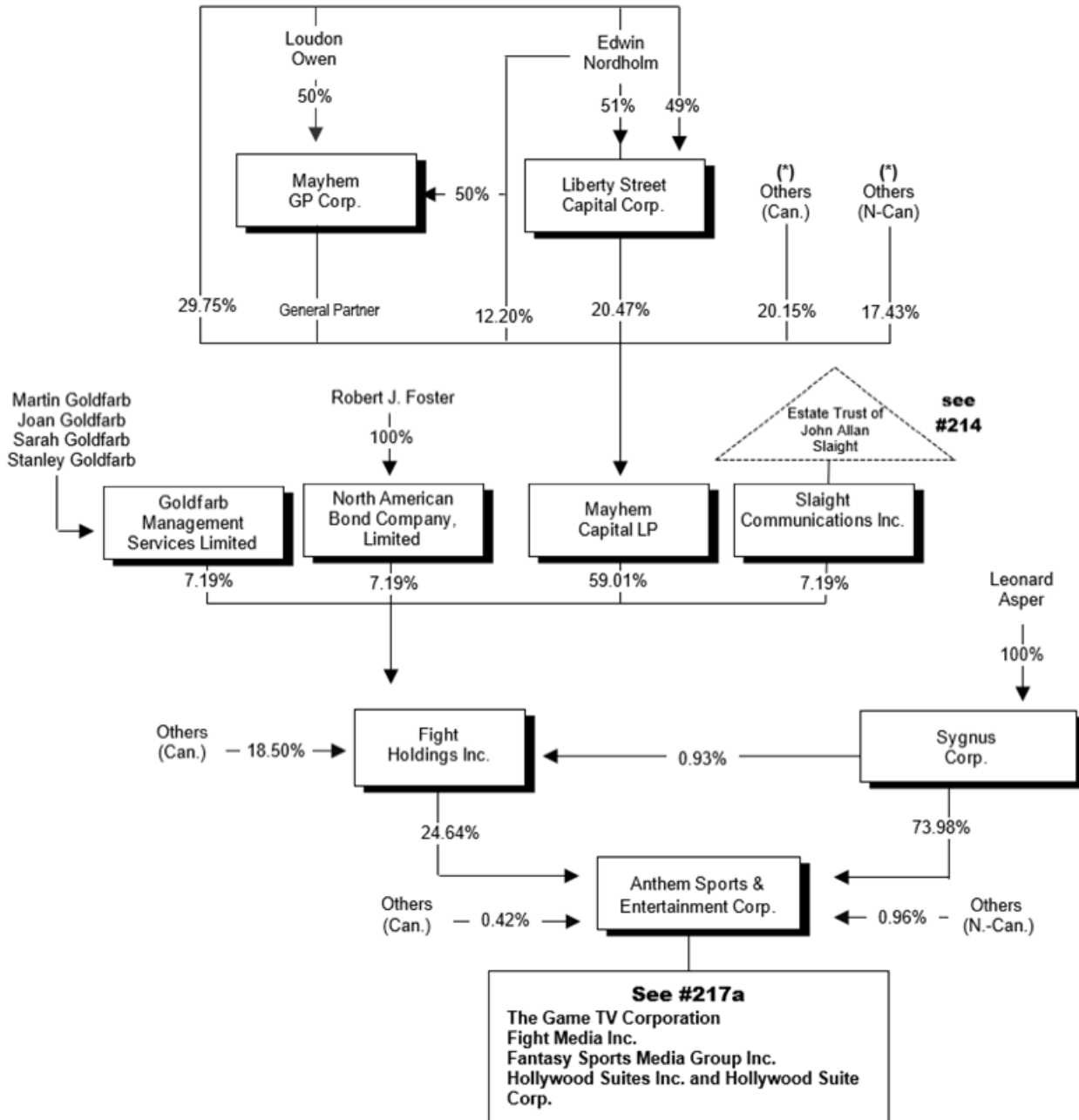


# ANTHEM SPORTS & ENTERTAINMENT CORP.

## UPDATES

**CRTC 2016-40** – approved a corporate reorganization resulting in the acquisition by Fantasy Sports Media Group Inc. of the assets of the specialty Category B service FNTSY Sports Network (formerly known as The League – Fantasy Sports TV) from Fight Media Inc.

**Administrative Decision** – 2016-11-25 – approved a change in effective control of The GameTV Corporation through the transfer of all of its shares held by Kilmer Enterprises Inc. to Anthem Sports & Entertainment Corp. (2016-0763-1)

**Administrative Decision** – 2018-03-09 - approved a change in effective control of The GameTV Corporation through the transfer of all of its issued and outstanding shares to Remuda Media Inc. (2017-1182-0)

**Update** – 2018-08-16 – in a letter dated on 2018-07-23, confirmation that the transaction approved in Administrative Decision of 2018-03-09 (appl. 2017-1182-0) will not be implemented.

**Update** – 2019-09-04 – FNTSY Sports Network is now known as Game+.

**Update** – 2020-06-08 – EDGEsport approved in Decision CRTC 2014-475 was not implemented.

**Update** – 2020-08-14 – specialty services are now referred to as discretionary services

**Update** – 2024-11-01 - transfer of common shares held by Slight Communications Inc. to John Gary Slight.

**CRTC 2025-238**– Approved an application by Pembina Acquisition Corp. (Pembina), on behalf of Hollywood Suite Inc. (HSI) and Hollywood Suite Corp. (HSC), for authority to change the ownership and effective control of the English-language discretionary services:

- Hollywood Suite 70s+
- Hollywood Suite 80s & 90s
- Hollywood Suite 2000s
- Hollywood Suite 2010s+

Pembina is owned by The Game TV Corporation. Following this transaction, HSI and HSC will be owned by Pembina, and ultimately controlled by Leonard Asper. **Note:** The transaction closed on June 1, 2025.

### OWNERSHIP

Anthem Sports & Entertainment Corp. is held as follows:

- 73.98% by Sygnus Corp. which is 100% held by Leonard Asper
- 24.64% by Fight Holdings Inc. and
- 0.96% by other Non-Canadian shareholders
- 0.42% by other Canadian shareholders

The ownership structure of Fight Holdings Inc. is as follows:

- 59.01% held by Mayhem Capital LP
- 18.50% held by other Canadian shareholders
- 7.19% held by Slight Communications Inc. (see chart 214).
- 7.19% held by North American Bond Company, Limited which in turn is 100% held by Robert J. Foster
- 7.19% held by Goldfarb Management Services Limited which in turn is held by Martin Goldfarb, Joan Goldfarb, Sarah Goldfarb and Stanley Goldfarb and
- 0.93% held by Sygnus Corp.

The ownership structure of Mayhem Capital LP is as follows:

- 29.75% held by Loudon Owen
- 20.47% held by Liberty Street Capital Corp. which in turn is 51% held by Edwin Nordholm and 49% held by Loudon Owen
- 20.15% held by other Canadian shareholders, as limited partners holding less than 10%
- 17.43% held by other non-Canadian shareholders, as limited partners holding less than 10%
- 12.20% held by Edwin Nordholm

One unit is held by the general partner Mayhem GP Corp. Mayhem GP Corp. is 50% held by Loudon Owen and 50% held by Edwin Nordholm.

Anthem Sports & Entertainment Corp. holds:

- 100% of The GameTV Corporation
- 100% of Fight Media Inc.
- 100% of Fantasy Sports Media Group Inc.
- 100% of Hollywood Suites Inc. and Hollywood Suite Corp.
