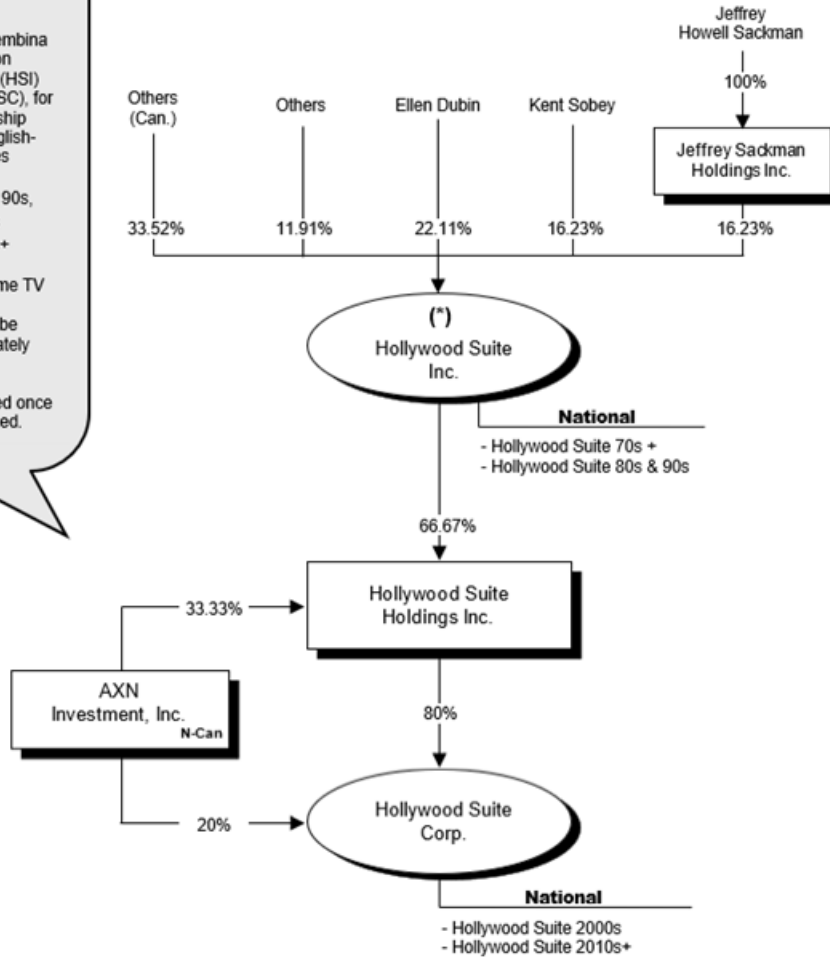

Hollywood Suite Inc. is held as follows:

- 22.11% by Ellen Dubin
- 16.23% by Kent Sobey
- 16.23% by Jeffrey Sackman Holdings Inc. which in turn is 100% held by Jeffrey Howell Sackman and
- 33.52% by other Canadian shareholders
- 11.91% by other shareholders

Hollywood Suite Inc. holds 66.67% in Hollywood Suite Holdings Inc. The other 33.33% is held by AXN Investment, Inc., a non-Canadian corporation.

Hollywood Suite Holdings Inc. holds 80% in Hollywood Suite Corp. The other 20% is held by AXN Investment, Inc.
