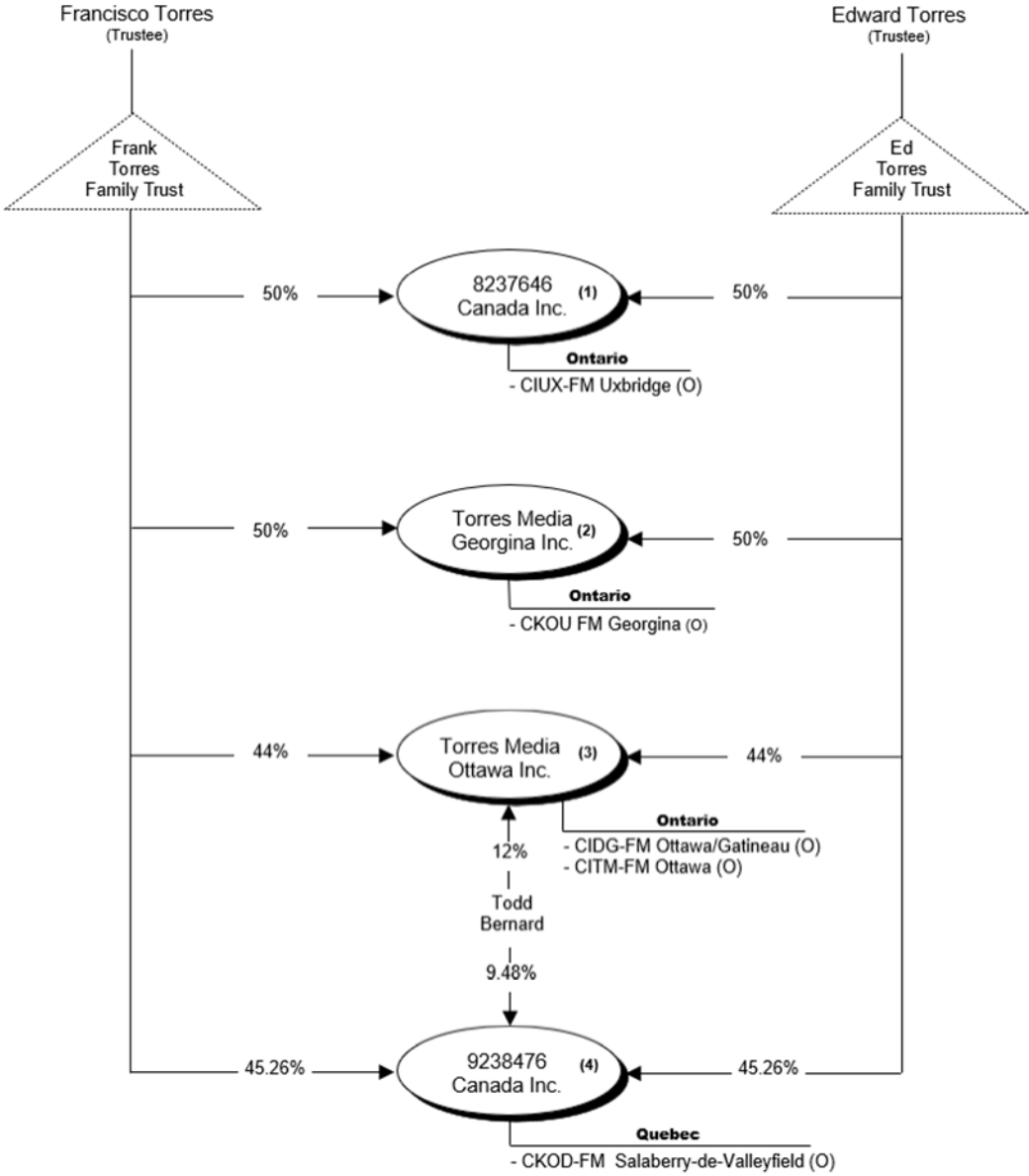


Torres Radio

UPDATE

Administrative Decision – 2014-12-30 – approved a change in effective control of 8237646 Canada Inc. from a group control by 3 shareholders (John Sherratt, Frank Torres and Edward Torres), to a legal control by Frank Torres, pursuant to the terms of the amended shareholders' agreement. (2014-1226-2)

Administrative Decision – 2015-05-08 – approved the temporary management by 9238476 Canada inc. (92387476), of CKOD-FM Salaberry-de-Valleyfield, pursuant to the terms of a temporary management agreement between Radio Express inc. and 9328476, a corporation owned by Todd Bernard, Yves Trottier, Ed Torres and Frank Torres. (2015-0327-7)

CRTC 2015-521 – approved the acquisition by 9238476 Canada Inc. of the assets of CKOD-FM Salaberry-de-Valleyfield from Radio Express inc.

CRTC 2018-238 – approved a new commercial FM radio station in Georgina, proposed by Frank Torres (OBCI).

Update – 2020-08-10 – incorporation of Torres Media Georgina Inc. on 11 February 2020, licensee of the FM radio station in Georgina.

Update – 2021-01-12 – of the shareholding of 9238476 Canada Inc.

CRTC 2025-163 – Approved a change in ownership and effective control of CITM-FM. Following the close of the transaction, the assets of CITM-FM will be transferred from Ottawa Media Inc. to Torres Media Ottawa Inc. **Note:** The transaction closed on July 10, 2025.
